Terms and Conditions

TEENAGERS AGE 14 TO 17

Mr. D's Driving School meets the States requirements for Teen Drivers Education. The classroom portion consists of 15 meetings, 2 hours each (30 total hours). The Behind-the-Wheel portion of the class is made up of 6 lessons, each being two hours in length (1hour driving/1 hour observing). All lessons, both classroom and BTW will meet at 601 South Illinois St, Belleville. Students are Responsible for transportation to and from all lessons. Mr. D's is not responsible for students prior to or after the completion of instruction time.

Teen Enrollment Requirements

1. Must be **15 years old on or before the last day of the classroom portion of the class.**
2. Students must provide verification that he /she is enrolled in school and has received passing grades. This can be verified in one of the following methods:

Form A/BLUE FORM – This form is approved by the Secretary of State. This form shows that the student is enrolled in school and has received passing grades in at least eight courses during the previous two semesters. This form must be taken to the student's school and be signed by a school administrator. (High School or Jr. High)

Form B/Yellow Form – This form is approved by the Secretary of State and is to be used to show proof that a student is enrolled in home school.

Form C/Pink Form – This form is a waiver that is approved by the Secretary of State. This form must be filled out and signed by the Superintendent of Schools. Students under rare circumstance may be approved by this form.

3. **Illinois Driving Permit**—Mr. D's can issue an application to obtain a permit up to **30** days prior to the class start date. To qualify:
- **Students must be 15.**
 - **Students must provide proof of passing grades.**
 - **Student must complete this contract, and be enrolled in the class.**
 - **Tuition must be paid in full.**

It is the responsibility of the student to obtain the permit from the Secretary of States office. Students are required to pass a written and a vision test before the Secretary of State will issue the Permit. Students must have a permit prior to driving with an instructor. Students are required to hold their permit for a minimum of (9) months, or until they turn 18, before obtaining a license. Students must complete 4 hours of classroom instruction prior to driving with an instructor.

4. **According to Illinois State Law, a Minimum of 30 hours of classroom instruction is required.** Any student absent for more than (4) class sessions will be dropped, and their permit will be rescinded. Students who are dropped will be required to reenroll and start the class over. Should re-enrollment be required, all funds previously collected will not be refunded, and new charges will apply. Any absences of (4) or less must be made up during one of our upcoming classes, and any missed work must be completed. All canceled classes due to weather or unforeseen circumstances will be made up at a later date. **Students must have a 75% overall average on test and quiz's to pass the class.**
5. **Driving Lessons**—Each Driving Session last for a total of (2) Hours. Two students are required to drive each session. Each student will drive for (1) Hour and Observe for (1) Hour. Students are required by Illinois State Law to complete a minimum of (6) Hours of Behind the Wheel Instruction, and (6) Hours of Observation. (These Hours do not count toward the additional (50) Hours of Practice Driving required by Illinois State Law) Students are required to give (24) hours notice of cancellation. Students who fail to give proper notice of cancellation, will be subject to a \$25 fee. Students will not be allowed to drive until this fee has been paid.
6. **Drive Time Scheduling**—Drive times will be posted at various times throughout the week and on the weekends. Students cannot drive during their scheduled class time. Mr. D's will not be responsible for students prior to or after the completion of instruction time. Students are allowed one driving session per day (1 HR Drive / 1 HR Observe), and must spread drive times out over a period of not less than 2 weeks.
7. **Deposit**—A deposit of \$100 is required to register for the class. The remainder of the tuition (\$325) is due the first day of class. Class size is limited to the first (35) students registered. There is a \$25 service charge on all returned checks.
8. **Payments** – Students who choose to make payments must be paid **“In FULL”** before being issued a permit application, and before Mr. D's Driving School will file any documents of completion with the state. No fees or interest charges will be added.

9. **Refunds—Mr. D’s Driving School Inc. will charge a \$10 Transaction Fee** to anyone who cancels a service with Mr. D’s. Students who cancel before the scheduled lessons begin would receive a full refund minus the \$10 transaction fee. All other refunds will be prorated based on how long the class has been in session or how many lessons have been provided. If a permit application has been issued it must be returned and permits already issued will be rescinded.
10. **Under the Influence** – Students will be dropped from class if found to be under the influence of Alcohol, or any illegal substances during class or drive time. **This is your only warning!! NO REFUNDS!**

Teens under 18 are required to complete the (30) classroom hours mandated by state law as well as drive for (6) hours and observe for (6) hours. Upon completion of all the requirements, and payments made in full, Mr. D’s will send the State of Illinois a letter of Certification. Students will then receive a letter from the State in about 2-5 weeks. Mr. D’s is only obligated to give six hours of driving instruction. If a student is unable to pass the Driving Portion of their driver’s exam, Mr. D’s will not be held responsible. Students who fail to complete their drive times within 9 months of their last scheduled class date, will be charged a \$25 reinstatement fee.

ADULT INSTRUCTION

Adults 18 and over must adhere to the same guidelines as stated above for the teens with the exception that they do not have to provide proof of passing grades in order to enroll.

Adults age 18 to 20 must pass a 30 Hour Drivers Education Class with Mr. D’s Driving School with a minimum of a 75% average in order to meet the State of Illinois Requirements. (Many of our competitors offer a 6 Hour Class which also meets the States minimum requirements, **students at least 17 and 3 months qualify for this**)

Adult Driving – Students must have a valid permit or Driver’s License in order to sign up for driving lessons. **All fees must be paid in full before scheduling any Driving Lessons.**

I have read and fully understand this above agreement.
